Hardy presents service awards for every five years of employment with the cooperative.

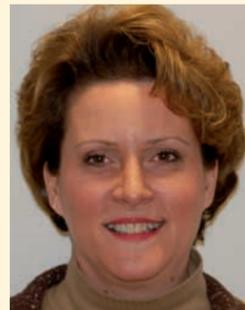

# Directors Pass Resolution For Glen Bradford; Board Slots Amended To Reflect Only Geographical Representation

Hardy's board of directors has passed a resolution in honor of Glen O. Bradford, who passed away October 5, 2009, after serving more than 34 years on the board.

"Glen worked tirelessly in the best interests of the members of the Cooperative so as to develop and further expand the services of the Cooperative," the directors said in the resolution.

Glen was a kind person not just in his capacity as director, but in his personal life as well, the directors said.

"In all aspects of his life, Glen approached every person and every project in a friendly and kind manner," the directors said in the resolution. They went on to cite his "contributions, wisdom, integrity, and selflessness that he brought to his position at Hardy Telecommunications."

A copy of the resolution, signed by Board President Phyllis B. Cook and General Manager Scott Sherman, was presented to Glen's surviving spouse, Charlotte Bradford.

Glen had served on Hardy's board of directors since 1975

as an at-large representative, meaning he did not represent any specific geographic region of Hardy's membership area.

The board recently decided not to fill the at-large position, opting instead to amend the company bylaws to reflect only geographical representation on the board of directors.

"This amendment to the bylaws ensures that geographic regions of our membership have representation on the board and is in the best interests of the cooperative," Scott said.

The cooperative is divided into three exchange service areas: Lost River, South Fork, and Moorefield. Current directors on the board include Lost River representatives Gerald Smith, Arlie Funk, Victoria Dyer, and Ervin Wilkins Jr.; South Fork representatives Phyllis Cook and Loring Barr; and Moorefield representatives Harold Michael and Greg Zirk.

Directors are elected to three-year terms, and cooperative members are eligible to vote for every director, regardless of their geographic region. Elections occur at Hardy's annual meeting each October.
